

Destroys mould, algae and lichens on all kinds of hard surfaces including **brick paving, patios, glass, perspex, garden furniture, walls, paved areas and driveways**. Also suitable for indoor use and as a pre-paint fungicidal wash.

**INSTRUCTIONS FOR USE:** SHAKE WELL BEFORE USE. **Application:** Apply to **dry surfaces** only. Always test on a small area before use. For normal infestations, dilute 1 part of product with 4 parts of water. For light infestations, dilute 1 part of product with 9 parts of water. Apply 1 litre of diluted product per 3-7m<sup>2</sup> of surface. Rinse out sprayer or watering can after use. Do not apply if rain is expected in the next 5-6 hours.
