

# **INSTRUCTIONS FOR USE:**

FOR USE ONLY AS A HOME GARDEN FUNGICIDE. For use on ornamental garden plants (indoors and outdoors). Use only between April and the end of September. READ ALL SAFETY INSTRUCTIONS BEFORE USE.

# WHEN TO USE:

April - September. Spray in calm conditions, avoiding bright sunlight, drought and frosts.

Protective treatments: Spray at the first sign of disease attack and repeat at 21 day intervals. For blackspot and rust on roses, the intervals may be extended to 28 days.

Existing disease problems: If disease is already established, spray at intervals of 14 days. Where roses were severely infected with blackspot the

previous season, spraying should start in spring as buds burst.

Maximum number of treatments: 5 per year.

## WHERE TO USE:

FungusClear<sup>®</sup> Ultra Gun! can be used on roses, other flowering and ornamental plants, trees, shrubs and conifers.

FungusClear® Ultra Gun! has been shown to be safe to many species and varieties of plants. However, it is always advisable to test a sample of plants, treating them and leaving for a few weeks before treating a large or valuable collection. Some leaf curling may occur on sensitive varieties of roses.

## HOW TO USE:

### Shake well before use.

Press down firmly on top of trigger head immediately behind the yellow nozzle to depress safety tab.

At the same time, twist nozzle to 'SPRAY' position 1/4 turn either way).

Spray plants thoroughly to wet upper and lower surfaces of leaves. Turn nozzle to stop position after use.

Contains 0.15 g/l triticonazole as a ready to use microemulsion formulation (ME).
