## WHEN TO USE

Use April – November, when weeds are actively growing.

**J F M A M J J A S O N D**

Use on a dry, calm day. Re-treat if rain falls within 6 hours of application.

## WHERE TO USE

Gravel areas, paths and drives, along fences, around sheds and greenhouses. Around the base of roses, ornamental shrubs, trees and under hedges (providing they are established, with woody bark). Take care to avoid drift! It's also ideal for ground clearance before autumn or spring digging and killing old lawns before reseeding or turfing.

## HOW TO USE

### SHAKE WELL BEFORE USE.

1. Press down firmly on top of trigger head immediately behind yellow nozzle to depress safety tab. At the same time, twist nozzle to spray position (1/4 turn either way).
2. Apply spray evenly to lightly wet the leaves avoiding run-off.
3. 1L treats: 37 m<sup>2</sup> of annual weeds, 34 m<sup>2</sup> of perennial weeds and 29 m<sup>2</sup> of brush weeds.
4. Turn the nozzle to off position after use.

**Visible effects in 24 hours. Weed death may take up to 28 days (in cold weather activity is slower).**

## TIP

**REPLANTING AND SOWING:** Treated area can be re-planted 7 days after spraying (to allow the weedkiller to move to the roots before cultivation).
