SAFETY INSTRUCTIONS

Protection during/in use

Wash hands and exposed skin after use.

Keep children and pets away from treated areas until spray has dried.

WASH OFF SPLASHES (IMMEDIATELY).

DO NOT BREATHE SPRAY.

If swallowed, seek medical advice immediately and show this container or label.

If spray is inhaled, take person into fresh air. If symptoms persist seek medical advice.

In case of contact with skin, immediately wash with soap and plenty of water. Wash contaminated clothes before re-use.

In case of contact with eyes, immediately wash with plenty of water for at least 15 minutes, also under eyelids. If symptoms persist, seek medical advice.

Environmental protection

Direct spray away from ponds and other surface water bodies.

Dangerous to bees. To protect bees and pollinating insects, do not apply to plants when in flower. Do not use where bees are actively foraging. Do not apply when flowering weeds are present.

Do not empty into drains.

Do not contaminate water with the product or its container.

Reasonable precautions must be taken to prevent access of birds, wild mammals and honey bees to treated crops. To minimise airborne environmental exposure, vents, doors and other openings must be closed during and after application until the applied product has fully settled.

Storage and disposal

KEEP PRODUCT IN ORIGINAL CONTAINER, tightly closed, in a safe place.

EMPTY CONTAINER COMPLETELY and dispose of safely.

INSTRUCTION FOR USE

FOR USE ONLY AS A HOME GARDEN INSECTICIDE TREATMENT.

READ ALL SAFETY INSTRUCTIONS BEFORE USE.

WHEN TO USE

Spray at first sign of insects or symptoms, until plants are clear of pests. For optimal control and persistence of effect, repeat applications are required at 7-10 day intervals. Further treatment may be necessary with other products. It is also essential to ensure comprehensive coverage of the plant surface, particularly the undersides of leaves.

The best time to spray is early morning or early evening, avoiding bright sunshine. DO NOT USE BugClear™ Ultra 2 during periods of high temperature (above 25°C) or when temperatures might become high during periods of high light intensity.

WHERE TO USE

BugClear™ Ultra 2 is ideal for ornamental plants. Do not spray directly onto blooms. Do not treat sensitive species of floral plants with delicate foliage, e.g. cyclamens.

HOW TO USE

1. SHAKE BOTTLE WELL BEFORE USE.
2. Using measuring cap provided, add 7ml/1L of water.

3. Half fill a pressurised sprayer with clean water before adding the required quantity of BugClear™ Ultra 2. Add the remainder of the water and mix thoroughly before use.

4. Mix and use immediately.

5. Spray evenly to wet upper and lower surfaces of leaves and stems of infested plants, avoiding open flowers.

6. Immediately after use, clean the spray equipment thoroughly.

Do not spray directly onto blooms. Do not treat sensitive species with delicate foliage, e.g. cyclamens.

As some plants may be sensitive to oils, it is always advisable to test a sample of plants by treating them and leaving for at least two weeks before treating a large or valuable collection.

Do not leave unused spray in the sprayer.

Any run-off onto undesirable surfaces should be washed away as staining can occur if the solution is allowed to dry.
