INSTRUCTIONS FOR USE

WHEN TO USE

Apply at the first signs of disease/attack and repeat application 10 days later if necessary. Do not exceed 2 applications per year. Do not apply when bees are actively foraging (use early in the morning or late in the evening).

WHERE TO USE

RoseClear® Ultra Gun! 2 is a combined insecticide plus systemic fungicide for use on roses. It will control aphids, as well as offering some protection against rust and blackspot.

HOW TO USE

SHAKE WELL BEFORE USE.

- 1. Press down the small tab on top of the nozzle firmly, where indicated.
- At the same time, twist the nozzle to the 'ON' position by turning 1/4 of a turn in either direction.
- 3. Spray plants thoroughly, including the underside of the leaves.
- After use, twist the nozzle back to the start position, ensuring the tab has reset to the locked position.
 - 1 Litre of product should be sufficient to treat 10 20 m2.
