

ANTSTOP!™ Granules contain Spinosad, an active ingredient derived from natural soil bacterium.

ANTSTOP!™ Granules have been designed to be easy to use and can destroy an entire ants nest with one application.

These dust-free granules have been formulated with sugar based carrier that actually attracts the ants.

ANTSTOP!™ Granules can be used in two ways:

Contact: Mix with water and pour directly on the ants/nest, or Ingestion: Sprinkling dry, over nests so the ants feed on the granules.

This advanced formula is not designed to kill ants instantly, so they take the ANTSTOP!™ back to the nest and the entire colony can be destroyed.

HOW TO OPEN:

Holding the container in two hands, press inwards firmly where indicated with both thumbs.

DIRECTIONS FOR USE:

Application Time: Apply at appearance.

Field of use	Application rate
Outdoor use (only for direct application to ant nests around domestic premises). Not for large-area application on hard surfaces (e.g. terraces or paved garden paths).	Apply this biocidal product directly to ant nests only. Do not scatter dry granules or pour liquid onto hard surfaces or bare soil used as ant runways. 1. Apply as dry granules at an application rate of 20 g product per nest or 2. Apply as a liquid drench at an application rate of 40 g product diluted in 2 litres of water, per nest. There should be an interval of at least 28 days before the product is reapplied. Measure 40 g product using the measuring cup provided. Add to 2 L of water in a watering can. Stir the mixture thoroughly, ensuring all granules dissolve. Apply over nest. After application, rinse the watering can with water and empty the rinsings on the treated area. Do not pour down drains.

If ants are still visible after 28 days, make a second application.
