## INSTRUCTIONS FOR USE

For use only as a home garden lawn treatment.

### When to apply

- ✓ Between March to September
- ✓ Actively growing lawns
- ✓ Moist conditions
- ✓ Weather is fair
- ✓ 4 days before mowing and 3 days after mowing.

### DO NOT APPLY

- During prolonged dry periods or frosty conditions
- When heavy rain is imminent
- On a windy day to avoid drift into beds & borders
- On a lawn less than 6 months old

### How much to use & how to apply

**Maximum** individual dose: 150mL per 10m<sup>2</sup>

**Maximum** 3 applications a year.

Mark out areas to be treated and apply evenly at the following rates:

Watering can: Dilute 150ml into 9L of water to treat 10m<sup>2</sup>.

Garden sprayer: Dilute 150ml into at least 500ml of water to treat 10m<sup>2</sup>.

\* A repeated application will help create a thicker, healthier lawn.

### What happens next

- ✓ Moss will blacken as it dies. Results will be visible in 7-14 days.
- ✓ Lawn is greener in 3 days.
- ✓ Rake out dead moss that has blackened after 2 weeks.
