### INSTRUCTIONS FOR USE:

FOR USE ONLY AS AN INSECT REPELLENT

### HOW TO USE:

1. Tear off the dispenser at the perforation.
2. Starting from the mark "Pull off here" to the perforation in the middle (marked with "hook") carefully remove the cardboard on the back.
3. Remove hook along the perforation, unfold.
3. Pull off the protective film of the now-visible rear side of the dispenser.
4. For best results, hang dispenser in upright position.
5. Make sure that the membrane/film is not covered by clothes and dispenser hangs freely.



### APPLICATION RATE:

Diffusion rate approx. 0.05 g per day, one dispenser lasts for 3 months after opening.

Replace after 3 months. For tightly filled wardrobes, use an additional dispenser. Suitable for continuous use.
