

## CAUTION

Kills all green plant growth and prevents seed germination. Avoid contact by spray and spray drift with cultivated plants and desired vegetation. To avoid transfer to lawns and other desired vegetation, do not walk into treated areas until the product has dried.

### Maximum number of treatments: 1 per year.

DO NOT apply to cultivated areas or lawns unless you want to kill them. If an area needs to be cultivated allow at least 6 months between treatment/replanting and dig the soil well to reduce risk of damage to subsequent planting. Where this or other products containing diflufenican are applied in successive years, diflufenican will build up in the soil. There is a risk of damage to subsequent plantings even if the soil is well dug.

## SAFETY INSTRUCTIONS

### Protection during / in use

Keep children and pets away from treated areas until spray has dried. Keep off skin. Wash off splashes immediately. Wash hands and exposed skin after use.

### Environmental protection

Use appropriate containment to avoid environmental contamination. Do not contaminate water with the product or its container. Do not empty into drains. Direct spray away from ponds and other surface water bodies. Do not apply during windy conditions so that spray does not drift onto other plants.

### Storage and disposal

Keep away from food, drink and animal feeding stuffs.

Keep product away from children and pets.

KEEP IN ORIGINAL CONTAINER, tightly closed, in a safe place.

EMPTY CONTAINER COMPLETELY and dispose of safely.

## INSTRUCTIONS FOR USE

## WHEN TO USE



Use March – September. Spray when the weeds are small and are actively growing. Use on a dry, calm day and do not apply in windy conditions. Do not apply if rain is expected within 6 hours of application. Avoid treating in waterlogged conditions. Apply to an area only once each year.

## WHERE TO USE

Weedol® Pathclear™ Weedkiller can be used for long-lasting weed-free gravel (or permeable) paths and drives overlying soil and on waste ground and for use around ornamental, trees, shrubs and other ornamental plants. Apply carefully making sure the product does not contact the foliage or trunk of these plants.

DO NOT use on impermeable surfaces or surfaces underlaid with impermeable material, such as concrete, tarmac, decking and paved areas, where the weedkiller solution might run off onto adjacent land, or into drains or gutters.

Direct spray away from water.

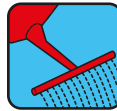
## HOW TO USE

### SHAKE WELL BEFORE USE.

1. Use either: Watering can with a Weedkiller Sprinkle Bar or a fine rose, or a garden sprayer.
2. Simply snap off (or cut open) the top of the tube and mix with 1 litre of water in a sprayer, or 5 litres of water in a watering can and mix thoroughly. Do not apply through, or store in, galvanised or unlined mild steel sprayers or watering cans.
3. Apply evenly on the area to be treated. Ensure weeds and soil are evenly wetted (on areas of dense or large weed cover, ensure the product makes contact with the soil, to prevent new weeds from germinating).
4. Wash equipment thoroughly with water after use and dispose of washings or any unwanted dilute product on soil in a waste area away from drains and gutters which is not going to be used to grow desirable plants within 2 years.

**Visible results in 14 days.**

**Weed death may take up to 28 days.**



## AMOUNT TO USE

Only make as much Weedol® Pathclear™ Weedkiller as you intend to use that day.

**Add one tube to:** **Sprayer:** 1 litre water  
**Watering can:** 5 litres water  
**Area treated:** 20 m<sup>2</sup>

## TIPS

The best weed control is achieved using hand-held pressurised spray application. If applying the product through a watering can with a dribble bar, optimum weed control may not always be achieved. To achieve optimum long-term weed control do not disturb the treated area.

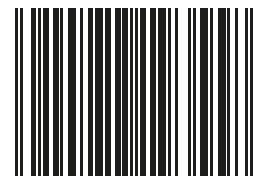
