INSTRUCTIONS FOR USE:

Open container, press inwards firmly where indicated with thumb. **FOR USE ONLY AS AN INSECTICIDE FOR AMATEUR USE.**

HOW TO USE:

By Drench: Dilute 20g in 1L water in a watering can and apply solution in 1m²

By Scatter: Apply 20g per m²

TIP:

Look for ant runs to help find and estimate the size of the nest. Adapt the quantity of product accordingly. In general, a nest covers 1m²

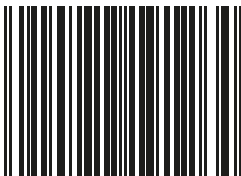
