The AntClear™ Control Spray Ultra provides protection from ants and can be used indoors (excluding food storage) and in protected outdoor premises, pathways, around the walls, cracks and crevices. Effective against a large range of household ants.

INSTRUCTIONS FOR USE:

FOR USE ONLY AS AN INSECTICIDE FOR AMATEUR USE.

HOW TO USE:

Shake product before application. Spray from a distance of 20 cm. Direct spraying: 1-3 pumps (approx. 2 ml). For surfaces treatment, spot applications & cracks & crevices: 50 ml/m². Apply to surfaces where ants are seen. In case of re-infestation, repeat the application.

SAFETY PRECAUTIONS & STORAGE:

- Use biocides safely and sustainably. It is illegal to use this product for uses or in a manner other than the prescribed on this label.
- USE ONLY AS DESCRIBED ON THE LABEL.
- Do not touch treated surfaces until fully dry.
- Keep children and pets away from treated areas until dry.
- Wash hands and exposed skin before meals and after use.
- Do not eat, drink or smoke when using the product.
- Do not contaminate foodstuffs, eating utensils or food contact surfaces. Do not apply directly on animals.
