# WHEN TO USE

# JAN FEB MAR APR MAY JUN JUL AUG SEP OCT NOV DEC

Outdoor use: apply pellets in mild damp conditions when slugs and snails are most active. If using in greenhouse, soil should be damp, not wet. Use pellets during the slug season when the first signs of slug or snail damage are visible on plants.

#### WHERE TO USE

Apply to bare soil around the base of strawberries, salad crops, brassicas, ornamentals and flowers to reduce slug and snail damage. Apply pellets evenly over the whole area of plants that you want to protect, ensuring that pellets do not rest on, or become trapped in, the leaves or other parts of the plants.

#### HOW TO USE

Sprinkle the pellets evenly and thinly over the soil around the plants to be protected, so that the individual pellets fall 8-10 cm (3-4 inches) apart (approximately 140 pellets or  $3 \text{ g/m}^2$ ).





Do not put on the ground in heaps.

Maximum individual dose: 3 g product per m<sup>2</sup>. 300 g is sufficient to treat 100 m<sup>2</sup>. Repeat application after 2 weeks indoor or 10 days outdoor if further protection is required.

### Maximum number of treatments per year: 4.

Avoid excessive irrigation or watering for a few days after application. Safety interval between last application and harvest or use and consumption: none.
