## INSTRUCTIONS FOR USE

FOR USE ONLY AS A HOME GARDEN LAWN WEEDKILLER. READ ALL SAFETY INSTRUCTIONS BEFORE USE. Keep children and pets away from treated areas until dry. To avoid drift, do not apply in windy conditions.

**Maximum individual dose:** 50 mL product per 25 m<sup>2</sup>.

**Maximum number of treatments:** 2 per year.

## WHEN TO USE



Use on leafy weeds April – September, when they are small, are actively growing and the soil is moist. • For best results following spraying, do not cut the grass for at least 1 day after treatment. • Avoid spraying in drought or frost. • To avoid drift, do not spray in windy conditions. • DO NOT USE ON NEW-SOWN LAWNS FOR AT LEAST 6 MONTHS AFTER ESTABLISHMENT. • Re-treatment may be necessary for well established difficult to control weeds. • Allow an interval of at least 6 weeks between treatments. • **Maximum 2 applications per year.**

## WHERE TO USE

For use on lawns. Kills perennial and broad-leaved weeds including dandelion, plantain, common chickweed, thistle, nettle and bramble. Doesn't kill the lawn. Targets to the root to prevent re-growth.

## HOW TO USE

### SHAKE WELL BEFORE USE AND USE MIXTURE IMMEDIATELY.

Wear gloves and enclosed footwear.



1. Use either a clean garden sprayer or watering can fitted with a fine rose.



2. Mix well before use. Loosen measure cap slightly, gently squeeze bottle until required volume is achieved. Apply Weedol® Tough Weed Control Concentrate at rate of 50 mL in 5 litres of water to cover 25 m<sup>2</sup> covering vegetation evenly.



3. Hold the sprayer or watering can rose approximately 20 cm away from the target weed and lightly wet the weeds - avoid run-off. For the majority of weeds a single spray is sufficient. Direct away from ponds and other surface water bodies.



4. Wash hands after use. Wash equipment thoroughly after use.

## CAUTION

The first 4 mowings of treated grass must be composted for 6 months before use as a mulch. Scorching of grass can occur if more than one squeeze is applied to a given area. Control may be reduced if rain falls within 24 hours of application.
