Section 4 - First Aid Measures

General Information:

Eye Contact: Quickly and gently brush particles from eyes. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water until the particles are removed, while holding the eyelid(s) open. Section 5 - Fire Fighting Measures

Section 6 - Accidental Release Measures
